- Remove the following words in strikeout to Section 2.7:
“A Store Front Cannabis Retail premises shall not contain a window ~~or window~~ facing a sidewalk.”
- Add the following words in underline to Section 2.7:
“A Store Front Cannabis Retail premises shall not contain a window facing a sidewalk or a Lane.”
